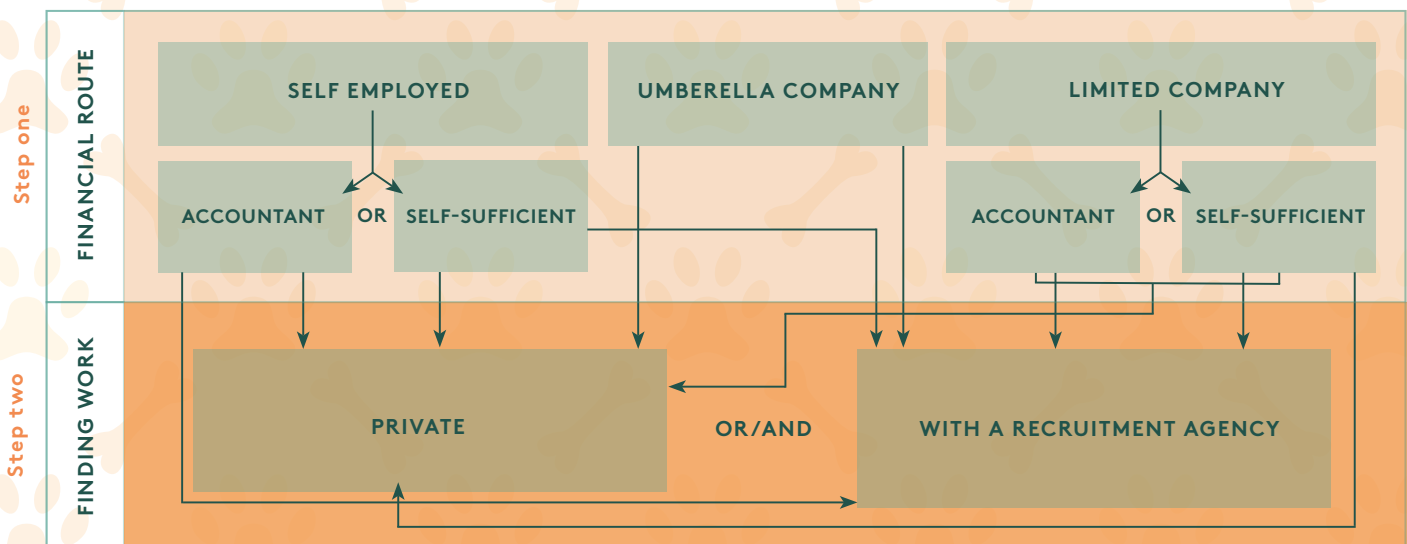

KEY with MollyFianderLtd

UMBERELLA COMPANY - An umbrella company act as an employer to contractors (YOU) who work on temporary contracts. They will collect your earnings from the recruitment agency or end client and pay the contractor minus deductions such as tax and the Umbrella Company's fee.

SELF EMPLOYED - Self employment is working for oneself rather than an employer. You receive no employer rights and are in charge on your own income and tax. Commonly known as 'Sole Trader'.



LIMITED COMPANY - A limited company is an organisation you set up to run your business which has its own legal identity away from the owners. You will need a separate bank account and to register with Company House. The owner of the company is legally responsible for its debts only to the extent of the amount of capital they invested.

ACCOUNTANT - An accountant ensures the business you have is running smoothly. They analyse budgets and data. They also complete tax returns and accounting records.


SELF-SUFFICIENT - You take the role of an accountant and file all your own tax returns and business records to ensure your organisation or business is correct according to the tax and business regulations.

PRIVATE - To find work yourself through research, word of mouth or contacting practices directly.

RECRUITMENT AGENCY - A recruitment agency works directly with employers to fill a role either as temporary or permanent cover. They match employees with employers and locums with temporary contracts.
